✓ The price for a three-day group visit to Berlin Brandenburg (with air transport from Belgrade, Zagreb or Ljubljana) for BSN/RCSEE members (with 20% of discount) per person is: 985,00 EUR

✓ Price for all other companies (non-members of BSN/RCSEE) per person is: 1.230,00 EUR

✓ Price for BSN/RCSEE members who independently organize air transport is: 720,00 EUR

Price includes:

- ✓ For passengers from Belgrade, Zagreb or Ljubljana (full arrangement) return airfare to Berlin and back;
- ✓ Three-day stay in a quality hotel (3 or 4 stars) including breakfast;
- ✓ Organization and coordination of the entire journey, including a visit to all the listed business associations and companies;
- ✓ Complete preparation of the event, with the delivery of information to German associations and companies about all companies/associations/institutions participating in the business visit and the animation of German participants, interesting for B2B participants from our side, in cooperation with Berlin Partner
- ✓ Announcement and promotion of the central B2B event and the visit of the delegation in the business print and electronic media of the Berlin Brandenburg region

Price does not include:

- The registration fee invoice will be sent on 29/30. January 2026. The deadline for payment will be 3 working days, due to the imminent date of the trip and the coverage of all costs from this offer.
- After January 28, 2026, **cancellation of the submitted application is not possible** and the registered participant is obliged to bear the full costs of the application, because after that date, BSN/Cluster will use its own funds to pay for plane tickets and hotel reservations, in order to provide plane tickets and accommodation for all trip participants in a timely manner. In the event of a change of person to whom an already paid airline ticket was issued, BSN/Cluster will not bear any additional costs, but only the registered party
